



2025 Apportionment for the State Wildlife Grants (SWG)

In 2001, the State Wildlife Grant program was established to support the conservation efforts of state and territorial fish and wildlife agencies for species of greatest conservation need as outlined in their State Wildlife Action Plans. These funds, allocated through annual General Appropriations, assist fish and wildlife agencies in states, territories, commonwealths, and the District of Columbia in developing and implementing programs that benefit fish, wildlife, and their habitats. Eligible projects include research, species restoration, habitat management, and other conservation measures aimed at safeguarding species of greatest conservation need,

To date, the program has awarded nearly \$1.4 billion in funding to support the species of greatest conservation need.

What do these funds do?

Support Species Recovery

Each year, SWG fundings support research and species restoration projects in the 56 U.S. states, territories, commonwealths, and the District of Columbia.

Conserve Habitats

Agencies manage, restore, and conserve critical habitats for species of greatest conservation need.

Develop State Wildlife Action Plans

SWG funds are used to support the development of State Wildlife Action Plans that guide the restoration efforts of species of greatest conservation need and their habitats.
