TARGET RANGE DEVELOPMENT & OPERATIONS



Wildlife Restoration funds (manufacturer's federal excise taxes) generated from the sale of firearms, ammunition, and archery equipment, support the construction, operation, and maintenance of over 850 public target ranges in the United States. This represents a significant investment in safe, structured environments where the public may participate in all kinds of target shooting.

In the last six months, there are 9 new ranges being built as well as 8 ranges being upgraded or expanded.














Since the 2019 'Tar-Mark' Act, there have been **412** grants submitted to build new ranges or upgrade/expand pre-existing ranges throughout the United States.

MidwayUSA Foundation's Range Development Grants

While the Range Development grants are meant for MidwayUSA Foundation Team and Agency endowment holders, certain non-endowment organizations such as conservation groups and universities may apply. Such applications must directly benefit local youth shooting teams, thus enabling greater youth involvement in shooting sports.

NRA Public Range Grant Funding

This matching grant program encourages city and county governments, and state or federal agencies, to work with the NRA to build and improve public ranges. At the NRA's sole discretion, grants assist with the acquisition, development, and improvement of public shooting facilities. Grants also assist qualifying agencies or governments with projects designed to improve community relations and to address environmental issues related to range operations.


The NRA Foundation is a 501(c)(3) charitable organization. As such, funded projects must promote an allowable 501(c)(3) purpose. If your range is owned by a government agency or is incorporated as a nonprofit entity or has an IRS 501(c) Determination Letter, your range may qualify for the grant.

Range Spotlight

Cedar Hills Gun Club (Rose, Idaho)

Exciting developments are underway at the Cedar Hills Gun Club, with support from Wildlife Restoration Grant funds! Latest projects include the construction of a new skeet shooting range, complete with concrete walkways and semicircular shooting stations, complementing the existing trap and rifle ranges. They are also enhancing accessibility with two new 2-space parking pads on the upper range. Additionally, a precast concrete double vault toilet will be installed, ensuring convenience for all visitors. To light up the ranges, the club is adding nine LED Sport Light stadium lights, providing excellent visibility for evening activities. Lastly, they are building a spacious 30' x 16' open covered shooting shelter for the pistol range, offering a comfortable and protected shooting experience.







Hank Harmon Public Target Shooting Range (Juneau, Alaska)

The Hank Harmon Public Shooting Range in Juneau, Alaska, received major upgrades in 2025 with WR funds to improve safety, accessibility, and overall functionality. Key improvements included new concrete shooting stations, upgraded shelters, expanded parking with drainage infrastructure, ADA-accessible features, improved signage, a new earth berm between ranges, realigned target berms, regraded surfaces, and upgraded access roads—all designed to meet NRA range standards. These enhancements ensure a safer, more user-friendly experience for local hunters and target shooters.
